As per Stockton University Procedure #2040: Life Cycle of Degree Programs, this memorandum serves as an official notification that the School of Social and Behavioral Sciences, PSYC Program faculty has collaborated with the School of Education, TEDU Program faculty to develop and adopt a new concentration, effective Fall 2018. Currently, a Bachelor of Arts in Psychology with a concentration in Elementary Education- Elementary Certification (K-6) with Specialization (6-8) is offered. The proposed concentration would add an additional path option for a BA in Psychology with a concentration in Early Childhood Education (P-3).

While the concentration is newly defined, it simply identifies and specifies existing psychology curriculum for students interested in P-3 certification and adds the Education and certification coursework requirements to be determined in consultation with Education preceptors. Please find attached documentation indicating both programs' approval of the proposed concentration. Changes to the existing concentration to specify a P-3 vs. K-6 path are minimal with slight variation in professional requirement and education courses to align with P-3 certification. (See draft curriculum worksheet for notations on variations.)

Details and the concentration requirements are specified below.

B.A. in Psychology with Early Childhood Concentration

The Psychology with Early Childhood Concentration is designed for those students seeking to earn a B.A. in Psychology and P-3 teacher certification. Although the university requires a 2.00 cumulative G.P.A., a 3.0 cumulative G.P.A. is the minimum requirement for NJDOE Certification. A grade of "C" or better is required in all PSYC courses and a "B-" or better in all professional education courses. (For a list of all education requirements, including Praxis Core and Praxis II tests, refer to the Teacher Education section of the Bulletin.) The student is responsible for ensuring that all graduation and teacher certification requirements are fully met. Students should consult with their designated preceptors in both PSYC and EDUC on a regular basis.

IMPORTANT NOTICE- As of November 2015, the New Jersey Department of Education has adopted updates to requirements for teacher preparation curriculum, clinical experience, and clinical practice leading to teacher certification. Candidates seeking certification in any area are encouraged to check the School of Education website (www.stockton.edu/educ) for updates to the program that will begin to take effect September 2017.<u>http://www.stockton.edu/educ</u>
