As per Stockton University Procedure #2040: Life Cycle of Degree Programs, this memorandum serves as an official notification that the School of Arts and Humanities, Studies in the Arts, ARTV Program faculty has collaborated with the School of Education, TEDU Program faculty to develop and adopt a new concentration, effective fall 2017.

While the concentration is newly defined, it simply identifies and specifies existing Visual Arts curriculum for students interested in K-12 certification and adds the Education and certification coursework requirements to be determined in consultation with Education

preceptors. Please find attached documentation indicating both programs' approval of the track.

Details and the concentration requirements are specified below.

B.A. in Visual Arts K-12 Certification Track

The Interdisciplinary Visual Arts Certification Track is designed for those students seeking to earn a B.A. in Visual Art with Teacher Certification. Although the university requires a 2.00 cumulative G.P.A., a 3.0 cumulative G.P.A. is the minimum requirement for NJDOE Certification. A grade of "C" or better is required in all ARTV courses and a "B-" or better in all professional education courses. (For a list of all education requirements, including Praxis Core and Praxis II tests, refer to the Teacher Education section of the Bulletin.) The student is responsible for ensuring that all graduation and teacher certification requirements are fully met. Students should consult with their designated preceptors in both ARTV and EDUC on a regular basis.

IMPORTANT NOTICE- As of November 2015, the New Jersey Department of Education has adopted updates to requirements for teacher preparation curriculum, clinical experience, and clinical practice leading to teacher certification. Candidates seeking certification in any area are encouraged to check the School of Education website (www.stockton.edu/educ) for updates to the program that will begin to take effect September 2017.http://www.stockton.edu/educ

Note: 1.) If a student wishes to opt out of the Visual Arts K-12 Certification Track, additional courses may be required to complete a B.A. in ARTV. 2.) Students should avoid taking 4000-level ARTV courses in the same semester as EDUC 4608 Methods of Teaching Art (4 credits) and EDUC 4990 Student Teaching (10 credits).
