## **STOCKTON UNIVERSITY SPEECH & HEARING CLINIC**



## **PURPOSE**

The Stockton University Speech & Hearing Clinic provides therapeutic and diagnostic services for children and adults with communication challenges and disorders. The services provided at the clinic are conducted by graduate students who work under the direct supervision of a licensed speech-language pathologist certified by the American Speech-Language-Hearing Association.

Therapy sessions are held for 50 minutes.

The clinical objectives addressed in therapy are determined by the results of the speech-language evaluation and are based on individual client need.

### FEES

The Speech & Hearing Clinic operates using a \$250 semester registration fee, which covers evaluation and treatment services for speech and/or language. Evaluative audiological services are charged separately. The Speech & Hearing Clinic's services are FREE to current full-time Stockton students.

#### DIRECTIONS

From the North (Northern New Jersey and New York, north of Parkway Exit 41) Take Garden State Parkway South to Exit 41. Turn right at the traffic light onto Jimmie Leeds Road. Turn left on Laurel Avenue (just past Clayton Storage). The clinic is on your right.

#### From the South (Southern New Jersey, south of Parkway Exit 41)

Take Garden State Parkway North to Exit 41, turn left at light onto Jimmie Leeds Road. Turn left again on Laurel Avenue (just past Clayton Storage). The clinic is on your right.

#### From the West (Camden/Philadelphia Area, west of Expressway, Exit 12)

Take Atlantic City Expressway to Exit 12W. Turn left onto Wrangleboro Road. Proceed through light at Route 30 (White Horse Pike), to next light at Jimmie Leeds Road. Turn right and proceed for approximately 2 miles to the clinic which will be on the right just before the entrance to the Garden State Parkway.
