## Approval of Minutes

Maribeth called the meeting to order at $4: 30 \mathrm{pm}$ and moved to approve the minutes from April 15, 2014, seconded by Carl.

## Academic Policies Committee

Maribeth yields the floor to Katerina to report for the Academic Policies Committee. Katerina reports that the faculty senate will be drafting a campus-wide attendance policy, which the committee will provide updates on once received. The committee will also be proposing a small break in between the last day of classes and finals in order to give students time to study.

Katerina yields the floor to Michael who provides a short update on another new proposal. Michael announces that he is currently working towards making preceptor meetings mandatory for all students. Due to the vague details on this subject, he encourages the public to see him after the meeting for questions.

Katerina yields the floor to Caleb. Caleb reports on the new constitution changes being made by Tuesday in regards to election changes. These changes will discuss giving students the right to vote for their president and vice president with complete details being presented at the next full meeting.

Katerina yields the floor back to Maribeth.

## Legislative Policies and Government Affairs Committee

Maribeth yields the floor to Maryam to report for the Legislative Policies and Government Affairs Committee. Maryam is pleased to announce the success of her first Higher Education Week event, which took place yesterday. The Scholarship Awareness Workshop was presented by Tom and provided great information on scholarships for students. Those who could not attend are welcome to see Tom after the meeting to answer any questions.

Maryam yields the floor to Angelo to provide a NY Times update. Angelo will be meeting with the Office of Service Learning tomorrow in regards to the New York Times and its increase on price per copy. Updates will be provided once a decision has been made on the $\$ 0.10$ increase. He is also pleased to announce that Kate Zernike will be presenting her panel in L-Wing on the Bridgegate Saga. Finally, Angelo reminds the public that hard copies of the NY Times are only available for free to students, not to faculty and staff.

Maryam updates the public on Jessica's current endeavors in her absence. Jessica has recently met with Jason in the Office of Student Rights and Responsibilities in regards to consequences for student violations. Jessica has proposed to establish a set of outlines, such as making senate training involve an understanding the campus hearing board as well as how the office works directly with students who come to them. Maryam yields the floor back to Maribeth.

## Public Relations Committee

Maribeth yields the floor to Michelle to report for the Public Relations Committee. The committee is currently working on elections, which will take place in about two weeks on April $14^{\text {th }}$ and $15^{\text {th }}$. Those interested in running for senate or board of trustees can still pick up
petitions anytime before Friday, April $4^{\text {th }}$, when all petitions are due. Photos of candidates will be taken this week for the Argo and a commercial the committee has been working on will be aired next week. A mandatory campaign rules meeting will be held on April $8^{\text {th }}$ in the Board of Trustees Room at 8 pm , followed by "Meet the Candidates" in the Coffeehouse on April $9{ }^{\text {th }}$ from 6-8. And last, the debate team will be co-hosting the presidential public speeches in Alton Auditorium on April $10^{\text {th }}$ from 8-10, which will allow all president and vice president candidates to present their speeches in a public form rather than doing so at the next full senate meeting. Michelle ends her report by announcing her committee's current partnering with the wellness center on "Denim Day" on April $23^{\text {rd }}$. The committee will provide further details at the next meeting regarding their plans for this day and how they plan to raise awareness on rape. Michelle yields the floor back to Maribeth.

## Student Welfare Committee

Maribeth yields the floor to Carl to report for the Student Welfare Committee. Carl thanks Trish for her hard work on getting all Pepsi machines fixed. He also announces that the student concern regarding the speed bump across from Big Blue has been addressed and will be replaced by next semester. Carl requests that students take the survey on Facebook regarding shuttle services and the new app, which has been aired for students to track shuttle arrivals.

Carl yields the floor to Murphy to report on residential life. Murphy announces that she has not met with RHA this week but has spoken to the liaison, Jenny Price instead. Murphy has met with members from the Stockton Coalition for Civic Engagement as well as some administration to discuss topics such as gender-neutral restrooms, gender-inclusive options for freshmen housing, and other topics to make campus Trans-friendly. In regards to the complaint on Buzzocracy about Housing 1, Murphy has met with Denise O’Neil, who has sat down with her and the student to discuss a resolution. Some issues have been resolved while others remain unable to be immediately addressed, but will continue to stay in the process of being corrected. Murphy would like to remind anyone that her and Denise are available to students for this purpose and are open to any other complaints that need to be discussed.

Carl yields the floor to Cristian to report on Athletics. Cristian recently checked on the issues at Big Blue and I-Wing, and has discovered that in comparison to last semester, there are very little, if any issues at all this semester. Directors at these locations would like to announce that they are aware of the broken equipment and have already scheduled to have it fixed. They ask that students remain patient during this time. Cristian has also in been in contact with Joe'l Ludovich, an associate professor in communications at Stockton, and has been working to address the ongoing student concerns regarding Wi-Fi accessibility on campus.

Lastly, Carl reports that the committee is still waiting on more information in regards to caps on student wages. He invites students to come to him with questions in the meantime but will continue to provide updates as they become available. Carl yields the floor back to Maribeth.

## Finance Committee

## CONSTITUTION CHANGES

## Re-election:

E. If someone has been removed from Student Senate, either by being impeached, recalled, accruing too many absences, or resigning from the Student Senate, he or she may not run for a position on the Student Senate.

Motion Passed: 2-2-0*

A former senator who resigned may appeal in writing to the Executive Cabinet to be exempt from E. The Executive Cabinet must address the appeal within 2 weeks of the day it was submitted.

## Presidential Election:

1. The Executive Cabinet will set the date of election and establish the necessary rules governing that election at its first meeting in the fall semester.
2. All presidential candidates in the election shall appear on a single ballot and the candidate receiving the most votes shall attain the position of President.
3. All vice presidential candidates in the election shall appear on a single ballot and the candidate receiving the most votes shall attain the position of Vice President.
4. A debate shall be held between all the candidates.
5. A senator may not accept nominations for both president and vice president positions.
6. If none of the senators meet one of the requirements for president or vice president, that requirement is temporarily suspended for all senators.

## The Student Senate Finance Committee submitted the Student Organization Budget for fiscal year 2015.

The budget approval process began with the Finance Committee deciding to reform the whole process. This decision was made with facts given of additional new organizations requesting budgets, and no increase from the school's administration to be allocated. Therefore, the Finance Committee came to an agreement to thoroughly review every organization's spending patterns and financial history.

First the committee updated the budget proposal form, which was lead by committee member Vice Chair, Kiyle Osgood. The form was sent to every student organization via email. There was also a link to the form on the Student Senate and Student Development webpage. The organizations were then asked to submit the form to the committee via email.

Next, the committee reviewed the submitted forms, organizations' current budget balance, and past fiscal years budget allocations to all organizations. The committee also took into consideration the impact the organizations had at Stockton College this past fiscal year. Once the committee reviewed all financial information of each organization, the committee then outlined meeting time slots for each organization. These meetings were to relay information to each organization of the state of their budget. It also helped the committee receive any additional input from the organization's representatives.

The committee then gathered any input from other senators, administration, and students. Their insight and guidance was greatly appreciated. After a week of intense studies and debates, the committee then convened and finalized the budget and submitted the outcome to each senate committee.

Overall 43 of the 68 incumbent organizations received moderate increases. 24 of the 68 incumbent organizations either received the same amount from fiscal year 2014, or received some type of a decrease. Only 1 of the 68 incumbent organizations did not receive a budget for next year. Lastly, there are 9 new organizations that that were qualified to receive a budget for fiscal year 2015.

In conclusion, there were many bumps along this process, and so many tough choices and decisions that were made. So the Finance Committee would like to thank every student organization for their patience and cooperation. We hope that the funds were allocated suitable to the students needs.
