Carl called the meeting to order at $4: 30 \mathrm{pm}$ and moved to approve the minutes from March $31^{\text {st }} 2015$, seconded by Angelo.

## President's Report

Carl had Tom Grites talk about the extended calendar for academic year 2015-2016. He said that a reading day was requested and passed last year in November. There were also multiple requests submitted, to the Provost office to look into moving the graduation ceremony, because it always fell on Mother's day. They began to look into what other state colleges were doing in terms of their academic calendar, and they found that they were far behind what everyone else had been doing. The Stockton University academic calendar was a week shorter than every other institution in the state. As they looked at the federal and state guidelines, they realized they were below the guideline for the semester hourly credit and they are exactly on target with the Monday, Wednesday, Friday class's schedule, and they fall short by a substantial credit of minutes. These definitions are all calculated into minutes. What they found is that they would have been ten days short in comparison to Montclair State, thus they made a prevision to be on target with the federal and state guidelines. They sent their calendar revisions to the office of the Provost, who is in charge of approving the schedule for the 2015-2016 calendar year. They also made sure that they included at least one reading day for students to study and more time for faculty to get grades in. There will be a similar grid for finials regarding location and allotted time for finials. If students have any questions for him concerning the academic schedule, they are more than welcome to reach out to him.

Carl went on to talk about his survey for food security that was given in February. He said that the survey showed that students do have a tremendous need on campus for some sort of food assistance program to help them make it through the day. He also said that it showed that a students' need increases drastically between their freshman and senior years. With this in mind, he said he will be working with Thomasa Gonzalez, Vice President for Student Affairs, on this to form a working committee that will be able to get this up and running for 2015, to address this matter so students aren't going hungry. He said more information will come as the program develops. He went on to announce that the President's State of the University Address will be given on April 8 ${ }^{\text {th }}, 2015$ at 5:00 pm in the Campus Center Theatre. He also announced that there is a job opportunity in the office of Student Rights and Responsibilities, they are asking for your support in serving on the campus hearing board for the 20152016 school year. If you are interested in applying for this job please reach out to the office.

## Vice President's Report

Louis announced that the EBI survey is out; and is about to close soon. He said if you live on campus, please take this survey, so Residential life can make sure that the institution is proactively addressing the needs of students who live on campus. They want to make sure that students are met. Louis went on to say that "Meet the Candidates" will be held on April $7^{\text {th }}$, and the elections will be held on April $14^{\text {th }}-16^{\text {th }}$. He hopes that students will vote so that their voices are heard. He also said that 24 -hour quiet hours will be starting on April $17^{\text {th }}$, which is also the day of the Spring Concert, so if students are going to this event they do want students to have fun, but to do it responsibly and to be mindful of obeying university policies. He also encouraged students to keep up their moral during this difficult time with the situation regarding the island campus in Atlantic City.

## Academic Affairs

Nick said that their committee has been working on forming a new committee for Student Senate, so that they can have more representation on the Senate. The Senate agreed to look further into the idea, so he will be working more with the SGA taskforce to submit a new proposal for it. He said that they will continue to look into new ways to see how each club can be better represented. He also mentioned that h Mike's survey, "Know Your CAPP", ends April $6^{\text {th }}$. He also announced that Mike will be looking into the classes that were suppose to be offered at the Island campus to find out where they will be offered in the Fall and if they will be offered at all.

## Government Affairs

Angelo yielded the floor to Maryam. She brought up that higher education week will be rescheduled for next semester. She also wanted to let students know that she is very proud of them for addressing their concerns about the Showboat and encouraged them to continue to keep up the good work. She yielded the floor back to Angelo. Angelo congratulated the Up-To-Us team on all of their hard work. He also wanted to address the concerns that were brought up on social media regarding the $\$ 10,000$ reward for winning this national competition. He said that the Argo will be publishing an official statement from the team on what they will be doing with the money. He also encouraged students to vote in the student senate elections. Lastly, Angelo informed students to do their research on their own to truly find out the details and logistics on what is happening with the Showboat and not to follow people based upon what they say, but based upon what they know.

## Public Relations

Lauren yielded the floor to Victoria Dambroski. She announced that they have a few fundraisers coming up. The first of many will be held on April $8^{\text {th }}$. They also have a fundraiser on April $9^{\text {th }}$ at Five Guys. Then on April $16^{\text {th }}$ at Moe's South West Grill from 5:00-8:00pm they will receive $20 \%$ of purchases with a flyer, so make sure you take a flyer. And lastly, on April $23^{\text {rd }}$ they will be back at Five Guys from 5:00-8:00pm, and there is no flyer necessary for Five Guys. Victoria yielded the floor back to Lauren. Lauren announced that the interest meeting for Senate Elections has already passed and that they had a great turnout of 41 students were interested in running. There was one more interest meeting that was added due to the one being canceled due to the snow day. She went on to say that on April $2^{\text {nd }}$ all the candidates who are running must attend the "Campaign Procedures Meeting" to become familiar with the official rules and guidelines for running in the senate elections. There will also be a "Meet the Candidates" session on April $7^{\text {th }}$ in the Campus Center Coffee House for students to get to know who is running for senate. She went on to announce that the "State of the University Address" will be held on April $8^{\text {th }}$ at 5:00 pm in the Campus Center Theatre. Presidential Speeches will be held on April $9^{\text {th }}$ at $8: 00 \mathrm{pm}$. She also said that the elections polls will be open from April $14^{\text {th }}-16^{\text {th }}$ from $12: 00 \mathrm{pm}-12: 00 \mathrm{pm}$. The committee is also working with student affairs to promote finding out how to address Wi-Fi related issues, thus they will be tabling with student affairs and working with telecommunications on getting this information out to students. They have also been working on coming up with a Wear Stockton Day, where if
you wear your Stockton gear there will be some type of incentive - more information is to come on this.

## Student Affairs

Murphy announced that her and Ar-Rasheed will be meeting with plant management and Trish, as well as doing Sweets for your Suggestions. They will also be working with residential life in removing the bulletin board for students who were concerned with it. She also said that Kaitlyn will be working with the learning access programs and is working on forming communities that will address these types of issues.

The Public Relations Committee had a very successful and productive year. In total, over seven hundred dollars was raised for Students Helping Students. A new fundraiser idea, selling merchandise at basketball games, was a success and accounted for a large portion of the money raised. New Stockton merchandise that was sold this year was rubber wristbands. During the spring semester, fundraisers were held at Buffalo Wild Wings and Five Guys Burgers and Fries. We collaborated with multiple Campus Center events and co-sponsored the Queen of Hearts Dance, which was a huge success with upwards of one hundred people attending. Along with these events, we also tabled at the Get Involved Fair, A Day in the Life, and Phoenix Nightmarket. All of these involvements gave Senate a stronger presence on campus. Developing uniform logos and slogans helped create a more unified and easily identifiable organization. Brochure, flowcharts and letterhead were developed to give Senate a look of professionalism. Programs started this year include Sweets for Your Suggestions and Students Helping Students Mentoring Program. We also created an Instagram account, and utilized the Senate Like Page and Twitter page to promote events. We updated the bulletin board, and started using a powerpoint before meetings to advertise all club events so there would be more time for public comments. We updated the petition and organized the election events including the Interest Meetings, Meet the Candidates and Presidential Speeches. We also put together a four page Senate Informer for this year, highlighting each committee's accomplishments, members of each committee and our new initiatives. This was emailed to the whole student body and placed as an insert in the Argos. All in all, this year was a successful year in the Public Relations Committee and we met and exceed our expectations giving Senate a more profound presence on campus and making students aware of what we are doing to solve the problems that affect them.

Shannon reached out to telecommunications with an idea to add outlets to the booths in the food court. Two emails have been sent to plant management with the idea awaiting reply.

Katelynn is also in touch with plant management so that we can see if this idea is possible. Katelynn is working hard to form a taskforce for the Learning Access Program for next semester.

Murphy met with Lonnie Folks to discuss NCBI in terms of gender inclusive restrooms and the accessibility of restrooms on campus and found a few new ideas and learned of some updates. Another gender inclusive bathroom will be available shortly in F-wing as soon as the gender inclusive sign is shipped it will be installed. Some of the ideas to make the restrooms more accessible would be automatic doors, or doors that do not close on their own. Murphy also met with Denise O'Neill and Chief Parker for a final update. Some of the accomplishments over this past year with our committee include the following; installing a hydration station in the upper campus center, improvements to veteran's park, hosting sweets for your suggestions with public relations, saw an increase in devices supported by telecommunications, addressed issues in policies for commuters in north lot, had hydration stations in the TRLC and lakeside lodge added to the 20/20 plans, addressed concerns about the cleanliness of the dance room floors, updated the information with regards to the Women's Gender and Sexuality Center, saw an increase in food options through the addition of Sono to lakeside lodge, another shuttle with a wheelchair lift, addressed concerns about osprey cam monitoring on campus, addressed
the lack of a representative on senate for students with accessibility and disability issues, evaluated the gender inclusive housing provided to freshman, and are working to form a taskforce to review the Learning Access Program.

Some of the issues that still need to be addressed include the following; finding ways to make facilities on campus more accessible, continuing to work with NCBI to provide more gender inclusive restrooms, adding more hydration stations in more areas around campus, providing more space in campus athletic facilities for the purpose of flatwork or yoga, adding more vegan, vegetarian, and gluten free options on campus, following up on the lights for the flags in veteran's park, and continuing programs like sweets for your suggestions in the future in order to reach out to students for issues we may have otherwise never realized.
